**SUBJECT: Important Updates to Payment Processing & Membership
Draft Dates.**

Dear Cumberland Cape Atlantic YMCA Members,

We appreciate your continued support and commitment to our organization. We are reaching out to inform you of some important updates regarding payment processing and membership draft dates, effective April 1st, 2025.

Credit Card Transactions – New Service Fee

Starting April 1st, a 3% service fee will be applied to all credit card transactions. This change is necessary to offset the rising costs associated with credit card processing. However, if you choose to make payments via **debit card/ACH or bank account/EFT, this fee will be waived.** We encourage you to consider these alternative payment methods to avoid additional charges.

Membership Draft Date Changes

To better streamline our billing process, our billing cycle will now be based on a calendar month and we are moving our membership draft days to the 1st or 15th of each month. **Beginning April 1st,** if you were previously drafted on the 10th of the month you will now be drafted on the 1st; or, if you were previously drafted on the 21st of the month you will now be drafted on the 15th.

We understand changes to payment processes can be an adjustment, and we appreciate your cooperation as we continue to improve every aspect of your member experience. Please see Member Services before March 28th to submit a new draft form if you wish to change your payment method or request the alternate draft date.
